Knights Templar commence their era with the organization of their order, ANNO ORDINIS (A.O.) "in the Year of the Order."

Order of High Priesthood dates from the year of the blessing of Abraham by the High Priest, Melchizedek, ANNO BONNEFACIO (A.B.) "in the Year of the Blessing."

RELIGIOUS/MEMORIAL SERVICES

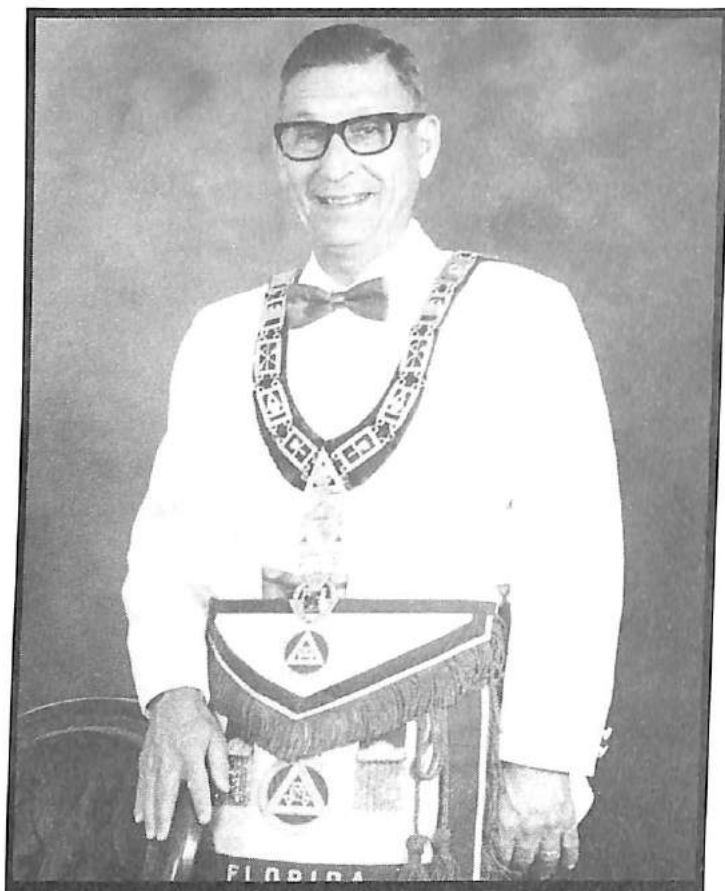

BUDGET & FINANCE COMMITTEE MEETING and RECOMMENDATIONS (Adopted)

The Budget and Finance Committee met on 12 February 1994 in Merritt Island Lodge No. 353 with the following members present.

R. Earl Shiver, Chairman; Earl R. Allan, Member; William O. Walker, Grand King; Duane B. Young, Grand Treasurer; and Mrs. Fran James representing the Grand Recorder's Office.

Projected revenue and funding were reviewed followed by an item-by-item look at the proposed budget.

A copy of the preliminary budget was distributed to all committee members, auditors, and the incoming Grand High priest.

The committee held its final meeting On 7 May 1994 at the Orlando North Hilton and Towers. At that time another item review of the budget was made resulting in the following recommended changes in the 1994-95 budget:

1. Account 00055 Host City Fund. This account will receive a one time funding, thereafter it will become an un-budgeted account. Moneys withdrawn will be replaced by the convention committee. Any excess funds will be deposited in the general fund. All financial actions involving this fund will become a part of the Grand Treasurer's report.

2. Account XX105 Postage. This account was increased from \$600.00 to \$700.00 in anticipated increase of postage rates.

SPECIAL LEGISLATIVE LIAISON COMMITTEE

The Legislature in its 1994 regular session and special sessions just concluded have passed "Senate Bill 3174" which will reduce the supplemental corporate fee to \$68.75. This to be effective January 1, 1995 when and if signed into law. This means that if each York Rite Body will pay the regular annual fee of \$66.75 or a total of \$130.00 for 1995. The bill should reach the governor's desk in about three weeks for his signature. There are also plans to further roll back the supplemental fee. We need to keep in contact with each of our own representatives to ensure this further relief.

RECOMMENDATIONS: 1. The Grand Presiding Officers request all York Rite Masons to contact their own Representative and Senator to the Florida Legislature expressing displeasure with this annual fee on not-for-profit corporations, and to file or support a bill for our relief.

2. The Annual Return and Fee be sent to the Grand York Office by the Constituent Bodies, so a consolidated record can be kept as to the status of which Body has filed and which has not, the forms checked and if properly filled out, then forwarded by the Grand Secretary to the Secretary of State, Corporation Division.

3. A close look at each Body's financial standing to see how this will effect them or if they need assistance.

REPORT OF COMMITTEE ON FOREIGN RELATIONS
(Adopted)

In our Proceedings of this Grand Chapter for the Convocation held in Orlando 17 May 1988 with M.E. J. Russell Hammond presiding, your Committee on Foreign Relations presented three reports.

One related to the Grand Chapter of Panama, with the recommendation that fraternal relations be established and Grand Representatives exchanged, which was adopted. At our Grand Convocation in Tampa in 1990, M.E. Companion Ralph O. Sheppard answered the roll call for Panama in 1992 and 1993 and he has made a number of visits to the Grand Chapter of Panama. He is not present with us today because of an important trip to Oregon for an occasion which he had to attend. He should be commended for his contacts in Latin America during the past 6 years while serving as the Deputy General Grand High Priest for that area.

A second report (1988) recommends that formal recognition be established with the Supreme Grand Chapter of Royal Arch Masons of South Australia, and that Grand Representatives be exchanged. The following year our present Rt/Ex Grand Scribe, Companion Davis, answered the roll call for South Australia, and has done so ever since. He has not yet been able to visit their Grand Chapter.

The third report related to the Grand Chapter of Royal Arch Masons of Greece. By edict of the General Grand High Priest in February of 1988, all of the Subordinate Chapters belonging to the General Grand Chapter were ordered to cease all fraternal relations with the Grand Chapter of Greece. This was related to the expulsion of the M.E. Grand High Priest of Greece, and several others from the Grand Lodge AF&AM of Greece. Your Committee on Foreign Relations at that time recommended that fraternal recognition, correspondence with, and visitation between, our two Grand Chapters cease. That recommendation was adopted by this Grand Chapter on 17 May 1988.

Although the Proceedings of the General Grand Chapter Triennial held last September at Biloxi, Mississippi, have not been received, evidence was presented indicating that peace and harmony have been restored. At this time (6 May 1994) a delegation from Greece is in the United States, and attempts have been, and are being made, to visit with the General Grand High Priest concerning these matters.

Later this month on 28 May 1994 to be specific, the annual Grand Convocation of the Grand Chapter of Royal ArchMasons of Nova Scotia (with jurisdiction over Nova Scotia, Prince Edward Island and Newfoundland) will be meeting for the last time at Gander in Newfoundland. There will be a single Grand Chapter at the beginning of the day, but after "splitting" there will be two Grand Chapters at the end of the day. You will see the emergence of a new Grand Chapter, namely the Grand Chapter of Newfoundland. The total number of Grand Chapters will remain the same.

I would call to your attention that there will be representation from all of the Northeastern states as well as Quebec, Ontario and even some from California on this auspicious occasion. Sixty-One Royal Arch Masons from the Grand Chapter of Canada in the Province of Ontario have made arrangements to attend.

The present Grand Chapter of Nova Scotia is in fraternal harmony with our Grand Chapter and their Grand Representative, Companion Robert A. Niles, is present with us today. It would seem prudent to recognize the new Grand Chapter, establish fraternal relations and exchange Grand Representatives, and your committee so recommends.

It should be noted that a new Grand Chapter of Royal Arch Masons is likely to be organized in Columbia in the near future.

Of interest to many at this meeting should be the establishment of a new Chapter of Royal Arch Masons in Portugal in the very near future.

While our Subordinate Chapters of Royal Arch Masons in Japan are suffering greatly, the Royal Craft is alive in one of the Chapters owing allegiance to the Supreme Grand Royal Arch Chapter of Scotland, namely the Chapter in KOBE. They were originally chartered about 1890, and then became inactive about the time of World War I. Beginning in the '70s some movement occurred, and about three years ago, in a ceremony of "Reponement" their Charter was "restored." You might wish to visit the Chapter in Kobe.

TRIENNIAL COMMITTEE REPORT

The 62nd Triennial Convocation of the General Grand Chapter of Royal Arch Masons International was held at Biloxi, Mississippi, September 12-16 1993. The Coliseum Convention Center on the beautiful gulf coast of Mississippi was the site of the august event. Several Hotels are located near the Convention Center and the logistics of travel, once there, was no problem.

The Grand Chapter Royal Arch Masons of Florida was very well represented on the occasion with twenty Companions and eleven of our ladies having made the trip.

Most Excellent Companion Harold Yaeger had an excellent triennium marked with steps toward the future and change in the administrative aspects of the General Grand Chapter. Fiscal matters were put to the square and altered, where necessary, allowing all aspects of our concerns to come under better financial planning and management. The Constitution and Standing Regulations of the General Grand Chapter were revised. The Craft in General Convocation voted to change the G.R.A.W. making the middle word "El" and dropping the presently used middle word. (Each grand jurisdiction independently decides if a change should be made.) He presided well, order, peace and harmony prevailed. There were 461 registered delegates. The Banquet was attended by 778.

Election of Officers for the Triennium (1993-96) was held and those elected were duly installed. Companion R. Glenn Capps, MEPGHP/NC, (lately of GA) as Most Excellent General Grand High Priest of Royal Arch Masons International. Companion Murray E. Cooke, MEPGHP/CA, as General Grand King; William Schoene Jr, MEPGHP/NJ, as General Grand Scribe; Companion Duane B. Young, MEPGHP/FL, as General Grand Treasurer; and Companion William R. Selby Sr, MEPGHP/KY, was elected to succeed himself as General Grand Secretary.

It was reassuring to see Florida so well represented. The General Grand Sentinel and also Regional Deputy General Grand High Priest was Most Excellent Vernon H. Miller. M.E. Companion Miller is currently Chairman of the Board of General Purposes. M.E. Companion Joseph C. LeSuer is assigned to the Youth Committee. Most Excellent Walter H. Winchester, MEPGGHP, is Chairman of the International Masonic Affairs Committee, member of the Bicentennial History Committee and member of the Education and Service Committee. Most Excellent James Russell Hammond, MEPGHP/FL, was Ambassador to Florida. Most Excellent Ralph O. Sheppard was re-appointed Deputy General Grand High Priest for Latin America.

The Deputy General Grand High Priest for the Southeast Region and General Grand Captain of the Host is Most Excellent W. Carroll Sanford, MEPGHP/NC, of Raleigh, North Carolina.

The next Triennial Convocation of the General Grand Chapter of Royal Arch Masons will be held at Asheville, North Carolina, in November of 1996.

We, the Triennial Committee, thank Most Excellent William L. Buck Jr and the Grand Chapter of Royal Arch Masons of Florida for allowing us the opportunity to serve.

I have visited 24 Royal Arch Chapters in the State, and spoken to the officers of 10 additional Chapters during those visits for a total of 34 Chapters, and attitudes are generally optimistic regardless of problems.

Regardless of losses due to deaths and suspensions for NPDs, there is a tremendous potential for our Grand Chapter in Florida to attain a much higher visibility and profile in the state, and to exercise a much greater influence on Freemasonry in general, and on

the lives of its members. Ego must always be subservient to the Good of the Craft, and positive attitudes developed to deal with problems. I'm appalled at the ignorance and misinformation about the York Rite and Royal Arch Masonry that exists in some of our Blue Lodges. The Grand Line Officers of the Grand Chapter, and Officers of our Constituent Chapters, as leaders, have a major, major, educational problem on their hands to get the Royal Arch Masonry message to our Blue Lodges. The fact that this problem even exists is scary, and this endeavor should be our highest priority in both thought and action. Ignorance has to be counter-attacked with knowledge.

I make the following recommendations to the Grand Chapter:

1. That the Ad Hoc Committee working on updating the Constitution, Rules and Regulations by comparing with the Grand Chapter Proceedings, be continued until the task is completed.
2. That the Committee on Work proceed immediately to complete my Directive to correct and revise the Essentials, and to produce a Ritualistic Aid to correlate the Maroon General Grand Chapter Ritual with our Florida Essentials. Our officers and ritualists need that help now.
3. That Grand Line Officers work with the Constituent Chapters to develop Blue Lodge Representatives that are effective in performing this highly important function.

CONCLUSION

To serve you, my Companions, has been an exhilarating, yet a sobering and humbling experience. I want to thank you with all the fervency and zeal in my being, for the high honor and privilege of serving York Rite Masonry in general, and Royal Arch Masonry in particular, as your Grand High Priest this year. It has been an experience that I'll always cherish memories of, and has provided new friendships worth far more than all the gold in Fort Knox. I love you all and it is my hope that GOD will allow me to serve the Craft for years to come. Let's all remember to think about what's best for the Craft, the Good of the Craft, The Craft - The Craft.

AD HOC COMMITTEE REPORT
(Received)

Report of the Ad Hoc Committee for the up-date of the Constitution, Laws and Regulations. The Constitution, Laws & Regulations of the Grand Chapter of Royal Arch Masons of Florida are declared to be the supreme law for this Grand Jurisdiction of Capitular Masons. It is essential to the good order of the Constituent Chapters and Companions that this Constitution, Laws and Regulations be maintained in an up-to-date and usable state for the administration of institutional affairs in a uniform manner.

A cursory review of the Constitution, Laws and Regulations reveals numerous grammatical or transitional errors, omission of pertinent information critical to adopted resolutions or amendments, and in some instances stand silent on fundamental laws and rules.

Therefore, William L. Buck, Most Excellent Grand High Priest, appointed this Ad Hoc Committee to study and review the Constitution, Laws and Regulations as adopted in 1987 and revised through 1989.

The purpose of the study and review was: (1) Determine corrections, amendments, additions, alterations or such clarification as may be deemed necessary or appropriate; (2) Prepare and present resolutions or legislation resulting from such studies and reviews to the Grand Chapter of Royal Arch Masons of Florida for adoption at a regular Grand Convocation; and (3) Prepare for the publication of such changes as appropriate and adopted by the Grand Convention.

The Committee undertook the task of reviewing Proceedings for the Grand Chapter of Royal Arch Masons of Florida for the past 30 years together with available supporting documentation.

Concurrently, resolutions and legislation adopted and recorded in those Proceedings were compared with the appropriate Article, Section or Regulation of the Constitution, Laws and Regulations to assure that each was included therein and that the language served the original intent and purpose.

Each committee member was assigned specific areas of legislation, proceedings, or supporting historical documents for review, study and comparison. Reports of specific findings with recommendations are quite revealing; and bears out the need for a one-time revision to up-date the Constitution with an annual up-date thereafter.

The designated work of this Ad Hoc Committee is approximately 45% completed which is on target with the estimated rate of progress forecast at time of appointment.

A resolution accompanies this report which recommends that the Grand High Priest reappoint this Committee for the Capitular year 1994-95 so that it may complete the assigned tasks and present appropriate legislation for adoption at the Grand Convocation in May 1995. The entire committee express their appreciation to M.E. Companion Buck for this opportunity to be of service to this Grand Chapter and to Capitular Freemasonry.

WHEREAS, The Constitution, Laws and Regulations, in their present state, contain numerous grammatical, printing or transitional errors; omissions of critical pertinent adopted resolutions or amendments; and, in some instances, stand silent on fundamental laws and rules essential for the execution of matters peculiar to Capitular Masonry.

NOW THEREFORE BE IT RESOLVED THAT the Grand High Priest be charged with the responsibility of having the existing Constitution, Laws and Regulations reviewed and, where necessary, rewritten or revised, and

BE IT FURTHER RESOLVED THAT the Grand High Priest reappoint the Ad Hoc Committee comprised of seven learned Companions (i.e. a Chairman and six members) to accomplish the work of this responsibility; and that said Committee pursue the objective so as to present a revision of the Constitution, Laws and Regulations for adoption by the Grand Chapter of Royal Arch Masons of Florida at the Annual Convocation in May 1995, A.I. 2525.

The Grand High Priest approved the By-Laws Amendments of Nine Chapters in a proper manner. Two Chapter By-Laws Amendments were not in a proper form and must be resubmitted to the Grand Chapter for approval. They are:

1. The 1-15-94 to Jackson Chapter No. 32.
2. The 2-15-94 to Putnam Chapter No. 9.

The Grand High Priest approved the By-Laws of two Chapters in a proper manner and two were not in proper form and must be resubmitted to the Grand Chapter for approval. They are: 1. By-Laws of Ocala Chapter No. 13.

2. By-Laws of Surf Chapter No. 57.

The reference being ARTICLE XIII, Section 13 of the Constitution.

While these Dispensations, ByLaw Amendments and By-Laws were granted in error, the intent was for the good of the craft. These errors strengthen the need for the revision of the Constitution, Laws and Regulations to clarify when actions by the constituent require dispensations and the proper form for By-Law Amendments.

This Committee commends the Most Excellent Grand High Priest for the excellent service and dedication he has rendered to Royal Arch Masonry in Florida. The Grand High Priest represented well this Grand Chapter in foreign jurisdictions, where he traveled.

REPORT OF THE COMMITTEE ON WORK (Adopted)

We are pleased to report the apparent increase of activities by Constituent Chapters during the past year, primarily under direction of this committee. Of course this could not have been accomplished, and successful, without the support and efforts of the M.E. Grand High Priest and his District Deputies, and for this support we are indeed grateful.

Many periods of instruction were held throughout the state, both in individual Chapters and as a District. The majority conformed to Grand Chapter regulations of having two sessions a year thus giving outgoing and incoming officers an opportunity to enhance their knowledge of floor and degree work.

Some instruction periods were informal with questions and answers. But at the request of District Deputies and Companions the majority was about opening, closing, the reception of Grand Officers, and questions about certain floor work in the other degrees.

We congratulate many Chapters for discontinuing the use of rituals in opening and closing ceremonies. It is the desire of this committee as well as the M.E. Grand High Priest that rituals not be used during Chapter ceremonies, except by a designated prompter.

We are pleased that information in the Red Book is becoming more effective and that Officers and Companions are becoming more efficient in floor work. However there are many questions among the Companions concerning differences in the General Grand Ritual (actually Maroon in color) and Florida "Red" Book", and as to which book is termed the "Red Book" and knowing this it has been the desire of M.E. Companion Buck to endeavor to clarify this.

We use the General Grand Chapter Ritual which does not provide for changes just for Florida, therefore the decision of the M.E. Grand High Priest and this committee was to check the articles in the Red Book that differ from those in the Ritual and to print and number them so they can be placed in the proper place in the ritual. Thus far the committee has completed the Mark Master, Past Master and Most Excellent Master Degrees. Progress is being made to complete the Royal Arch Degree.

Remember, Companions, in speaking of the Red Book we are referring to the book prepared by the Committee on Work and adopted by this Grand Chapter. The Ritual is maroon, not red.

We have been assured that the incoming Grand High Priest will instruct his District Deputies to consult with the High Priests in their districts and schedule a time and place for instruction and to inform the chairman of this committee as to time and place that a member can be present. We will be pleased to have a member of this committee present at a Chapter meeting at the request of the High Priest.

GRAND REPRESENTATIVES PROGRAM COMMITTEE REPORT

Members of the Committee began studying the challenges presented by participation (or lack of it) 20 years ago, and presented a report at our Annual Grand Convocation at Ft Walton Beach 24 May 1989, together with many recommendations for providing new incentives to make the system of Grand Representatives productive. This was adopted without dissent. This will be found in the Proceedings of 1989 pages 26-28.

Each year since then this committee has anticipated there might be some changes evident. Therefore, to analyze where we stand after five years, our 78 current Grand Representatives near our Grand Chapter of Florida were written requesting various sorts of information. 33 responded (about 43%). 45 did not even reply (57%).

Almost all those serving as Grand Representatives were current or past grand officers and/or recipients of special awards for distinguished service in one or more of the four Grand York Rite Bodies.

(Continuation of Grand Representatives Report)

They excelled in answering the annual Roll Call, but when describing what they had done in the way of communication, half said they hadn't even tried to communicate with either the Grand Chapter or their counterpart. Half apparently tried a letter or two, but the majority received no reply. A few then tried writing the Grand Secretary of their particular area - and again, no response. There was one exception and a good relation was established with at least one Grand Secretary. Only a small number admitted to having received or seen the Proceedings from the Grand Chapter that they were representing. Your Chairman and the members of this committee fall into the same category. In my case, repeated efforts at contacting my counterpart in Hawaii met with blank walls, and discouragement takes over, with apathy ruling the day.

It is reasonable to presume that those who did not respond to this inquiry had accomplished still less, and were unwilling to so state.

On the other hand there were seven who made a special effort by exchanging visits. The one who traveled the greatest distance and who apparently had the most satisfaction in doing so was Ralph Jones Jr when he visited Israel. He continues to correspond with his counterpart. They became real friends.

Another who visited his Grand Chapter repeatedly is Floyd Ziegler, who has visited the Grand Chapter of West Virginia nine times. This is a unique situation and though a working man when he was in West Virginia, he has made those special efforts and enjoyed it.

In general, those who replied to the request for their experience seem to be delighted with the "honor" of the appointment. But for the most part they did little or nothing to be able to continue "qualifying" for it. In effect, it was an "empty" honor, and greatly inferior to the Masonic Honors of the office or accomplishment, he had previously attained.

Your committee urges each of our Grand Chapter officers to reread the 1989 report which was adopted and begin the process of locating men who:

- 1) Want the job or challenge in the first place,
- 2) Have been in the Royal Arch for only a short time (perhaps a couple of years),
- 3) Who are willing to make some supreme effort to develop a working friendship with a like-minded counterpart
- 4) Discovers the fun of sharing his story with others at Grand Chapter. A source of new leadership material is thus uncovered.

However, as in prior reports by this committee there are still some "bumpy" roads out there, and from your committee's observations, will continue to be so for some time to come. Therefore, some parts of our report might seem to bode evil and cast a "black" shadow over and within the fraternity as a whole, but everything is not all bad and we haven't gone "down the tube" yet.

In regards to "world-wide" relations within Grand Lodges, there is still much concern in what is happening in some emerging countries in Europe, and it should be noted that some of the "older" jurisdictions, particularly Italy where there are two Grand Lodges fighting for universal recognition. Some of our Grand Lodges within the Continental United States no longer recognize each other, it is therefore the feeling of the committee that this concern should be transmitted to those here assembled that should this trend continue, it could eventually effect these Grand York Rite Bodies and their recognition of other Grand York Rite Bodies. Example; Since The Grand Lodge of Oregon, no longer recognizes the Grand Lodge of Idaho, can the Grand York Rite Bodies in those states technically extend recognition???

There is also much to do about the present Imperial Potentate of the Shrine of North America, who is strongly advocating a departure from their traditional linkage with the York and Scottish Rites as prerequisites to membership in the Shrine. Should he succeed in his goal, then you may rest assured that it will with certainty, effectively drive our membership considerably lower than it is today.

Not only are we fighting amongst ourselves, but our religious adversaries (fundamentalist) keep pounding at our doors, attacking from every quarter. It is past time that we, who love this fraternity and to we have committed so much of our energies, to strike back in this one area, but this can only be done by arming ourselves with knowledge - knowledge of our fraternity which will in turn, give us the mental ammunition to strike back with the TRUTH as we know it to be.

It would appear that problems most concerning our sister jurisdictions is much the same as ours. That concern is the loss of membership and that loss appears to be growing in intensity among Grand Lodges from whom we draw our membership. Some Grand Lodges, including Florida are organizing from within and beginning to move toward what they hope will resolve some of the problems. In consequence of their action, many of our Particular Lodges are now raising younger Master Masons upon whom we must someday depend on their taking our places here in these Grand York Rite Bodies. You may ask "just what does this have to do with Fraternal Relations?" Perhaps nothing, but we should take advantage of these happenings in our Grand Lodge(s) and climb aboard their "band wagon" by recruiting younger Masons NOW, for they are the future of our fraternity and the ones through whom we transmit the traditions and teachings of the fraternity, for their transmission to future generations.

ROYAL ARCH RESEARCH ASSISTANCE COMMITTEE REPORT
(Adopted)

Following is the report of progress and activities of the Royal Arch Research Assistance Program for the Capitular Year 1993-94. The Companions of the Most Excellent Grand Chapter of Royal Arch Masons of Florida continue their fine support of the General Grand Chapter Royal Arch Masons International philanthropy for the seventeenth year. The effort this year has been satisfactory although we did not attain the goal we had set for ourselves.

During this reporting period thirty-one Chapters and ten honorary organizations, which includes the York Rite Ladies Boutique, have supported our charity. The Companions of Florida and the organizations that supported them in their effort have contributed a total of \$8,326.16 of which \$7,625.93 was made in the form of general contributions and \$610.00 was made Memorial contributions. It was regularly voted to Lifetime Honorary Membership on all Distinguished Guests who had not previously been so honored.

REPORT OF THE GRAND CHAPTER MEMBERSHIP COMMITTEE
WITH BLUE LODGE REPRESENTATIVE PROGRAM

You supplied the Chairman of the Committee with a list of names of Master Masons prior to the Grand Convocation in May 1993. In June the Membership Office made a Database on Microsoft Works computer program. The original list supplied by you had the name, address and Blue Lodge number of 1,250 newly Raised Master Masons. The list was in numerical order by the number of the Blue Lodge, the York Rite Body, District and Zone. The list became 1,250 because of obvious errors in names, addresses, or incomplete data. This process occupied at least 60 hours.

We then found the names in each District and assigned a Committeeman to each of the ten Districts. About 10 hrs was involved in this.

On June 18 this office ordered 1,500 copies each of the following publications. From the General Grand Chapter:

"The Necessity of the Royal Arch to the Master Mason" by W.F.Kuhn.

"What Every Master Mason Should Know" by General Grand Chapter.

"More Light" by the York Rite Bodies of Florida.

The item cost was \$0.20, \$0.15, and \$0.08 respectively.

On June 19, 1993 this office mailed a list of the names only to each of the Secretaries and Committeemen so that the list may be pared down by eliminating those men from the list who may have already become members. This was accomplished with some difficulty as it took some phone calls to obtain a list of the Chapter Secretaries and High Priests. Even then several were not correct. A letter was enclosed with the lists having your approval. Included in the letter was a request to name the Blue Lodge Representatives in their areas.

The response from this letter was from 14 Secretaries noting that there were 18 names who were already members and bringing our Blue Lodge Reps. to 44.

On July 26 we mailed out 1,210 envelopes stuffed with a page and a half letter of welcome - introduction - invitation letter from you, the Grand High Priest; a two page letter from M.W. and M.E. Franklin C. Smith of information - invitation, the three pamphlets that were named above, and a letter of graphics with a tear away form to request a Petition. About 70 hrs was involved in this endeavor.

About one week later complete packets were mailed to all Blue Lodge Representatives, (Excellent High Priests where there were no Blue Lodge Reps. named), D.D.G.H.P.s and Membership Committeemen. The packet contained the two letters of invitation, three pamphlets, the Petition request form, and (for each Committeeman a complete list of the names, addresses, Lodges etc. of each prospect in his assigned Zone), the District Deputies and Blue Lodge Reps. got a list that contained the prospects etc. in their smaller areas.

(Continuing Membership and Blue Lodge Committees)

A response was requested by September of 1993. We mailed a copy of all this information, excluding the lists, to the three Grand Presiding Officers of the Grand York. About 12 hours was involved including stuffing and mailing.

On August 6, 1993 this office recorded the names etc. of new Lodge Reps., Two hours computer time. August 12, recorded new Reps. and data, one hour on computer.

January 16, 1994 sent letters to all E.H.P.'s, Blue Lodge Reps, and Committeemen requesting that they report the findings and activities in their respective areas. Three hours involved.

This office has received 17 mailbacks of the petition request form from the prospects. the Chairman personally called a Lodge Rep. or some other member in that locale that he thought would go see the petitioner and initiate the proper action right away. There have been no reports back from these telephone calls as to Exaltation of the prospect. No record was kept in the office of phone time.

As of today there are 69 Blue Lodge Representatives named.

As of this date this office has received 17 responses from Blue Lodge Representatives or D.D.G.H.P.'s.

Recommendations: 1. I think that many more zealous and active Blue Lodge are needed. They should receive personal letters from the Grand High Priests or the three Grand Presiding Officers explaining their job, i.e.; Frank Smith's old letter.

(Continuing Membership & Blue Lodge Committees)

2. This original list of names should be contacted by individuals in the local area, eye to eye, or at least by phone locally.

3. Obtain an updated list from the Grand Lodge that run from the last of the first or current list to the present.

4. Change Committeemen. Have a Committeeman from each district. They should be informed that they need to work and produce results or give up the title to someone who will make that earnest effort. Since in many cases the District Deputy does little then he might be asked to further EARN the title by working on Membership. Possibly working on membership and obtaining positive results might assist in producing the honor of the title District Deputy _ _.

5. The program needs to be continued and expanded upon. The results produced here, about 1/3 of 1 percent, are certainly poor. There must be a concerted local effort to increase the membership of the Royal Arch Chapters, thereby increasing the membership in the Councils and Commanderies. A list of prospects to contact locally is a good place to begin. The past many years have shown we are not doing it right. This may be the right start, let's try it a while and give it emphasis on both the state and local levels.

6. I think there should be state awards and very special recognition given to those men who are responsible for getting petitions in. In defense of that statement I urge you to look at the other Rite and its's membership. Several of the Valleys in this state have more members than this Rite does in the WHOLE STATE. We know ours is the oldest, we know it is the purest. We MUST merchandise it better than we have. Let's find a plan to honor first line signers without using red or white hats.

We want to thank Most Excellent Companion Buck and the Grand Chapter of Royal Arch Masons of Florida for allowing us the opportunity to serve during the year.

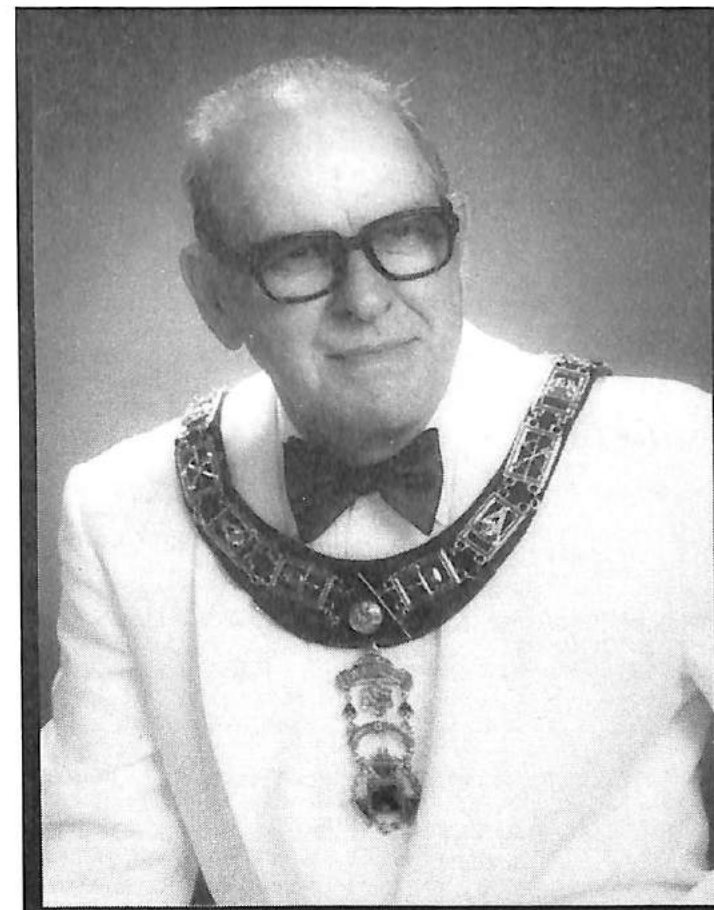
