MASONIC CALENDAR

Ancient Craft Masons commence their era with the creation of the world, calling it ANNO LUCIS (A.L.) "in the Year of Light."

Scottish Rite differs from the Ancient Craft in that they use the Jewish chronology, ANNO MUNDI (A.M.) "in the Year of the World"

Royal Arch Masons date theirs from the year the second temple was commenced by Zerubbabel, ANNO INVENTIONIS (A.I.) "in the Year of Discovery."

Royal and Select Masters (Cryptic Masons) use the completion date of King Solomon's Temple, ANNO DEPOSITIONIS (A.Dep.) "in the Year of Deposit."

Knights Templar commence their era with the organization of their order, ANNO ORDINIS (A.O.) "in the Year of the Order."

Order of High Priesthood dates from the year of the blessing of Abraham by the High Priest, Melchizedek, ANNO BONNEFACIO (A.B.) "in the Year of the Blessing."

Ancient Craft Masons - (Add 4000 years to the common era)
Thus 1995 and 4000 = 5995

Scottish Rite - (Add 3760 years to the common era)
Thus 1995 and 3760 = 5755

Royal Arch - (Add 530 years to the vulgar year)
Thus 1995 and 530 = 2525

Royal & Select Masters - (Add 1000 years to the common year)
Thus 1995 and 1000 = 2995

Knights Templar (From the Christian era take 1118)
Thus 1118 from 1995 = 877

Order of High Priesthood - (Add to the Christian era 1913)
Thus 1995 and 1913 = 3908

RELIGIOUS/MEMORIAL SERVICES



**REPORT OF THE GRAND CHAPTER MEMBERSHIP COMMITTEE
WITH BLUE LODGE REPRESENTATIVE PROGRAM**

This committee was tasked with two main responsibilities during the past year. The first was to continue past efforts to solicit new York Rite Masons from the rolls of newly made Master Masons. The second, but no less important, was to revitalize the Blue Lodge Representative program.

The Chairman of the Committees was again supplied with a list of names of new Master Masons which were input into a database. This list was broken down by district and your District Deputies supplied with a list of those Master Masons within his district. This list was in turn broken down and distributed to the various chapters within the respective districts.

A request was then made to the District Deputies that they, with the Chapters in their District, "pare" the list by eliminating those Brothers who had become York Rite Masons and those who had moved from the jurisdiction.

Finally respective Chapters were encouraged to make use of these finalized lists to solicit new candidates for the York Rite Bodies. The results of these endeavors to be reported to the District Deputies and they to the Chairman of this committee.

As to be expected these programs have met with varying degrees of success. Some Districts have been quite successful in utilizing the lists of Master Masons to recruit candidates. Other areas have carried this a step further and solicited the local Lodges for lists of older members who are not York Rite Masons.

Other Districts have had marginal results with both programs for a variety of reasons. In some areas local Blue Lodge secretaries have been unwilling to cooperate in some of the fact gathering efforts.

This committee makes the following recommendations:

1. A continuation of the Blue Lodge Representative Program and continued and concentrated effort to solicit representatives who are in regular contact with the new members of their particular Lodges. Also that those who are appointed representatives are sufficiently knowledgeable to properly present a picture of the York Rite. (An education program might be in order here)
2. That the program of providing lists of new Master Masons be continued.
3. A return to an organized effort of retention and revitalization of current membership. A particular effort being made to make our meetings more interesting and of a proper length.

The Committee wishes to thank Most Excellent William O. Walker for the opportunity to serve the Grand Chapter of Royal Arch Masons of Florida and the Companions that are the life blood of this fraternity.

FRATERNAL RELATIONS COMMITTEE

To the Most Excellent Grand High Priest William O. Walker, Officers and Members of the Grand Chapter Royal Arch Masons of Florida:

Your Committee is appreciative of the presence of the General Grand High Priest of the General Grand Chapter, Royal Arch Masons, International, R. Glenn Capps. We urge each of you to visit with him and learn of Grand Chapters in far off places.

Your Committee on Fraternal Relations has had but one request for fraternal recognition during the past year, namely that from the Supreme Grand Chapter of Royal Arch Masons of Greece.

The General Grand Chapter, Royal Arch Masons, International, in February of 1988 issued an edict calling upon their Subordinate Chapters of Royal Arch Masons and not a member of sovereign Grand Chapters to cease any masonic intercourse with that Supreme Grand Chapter. This action was taken because the Grand Lodge in Greece expelled the York Rite and its officers who then proceeded to form another Grand Lodge and another Grand Chapter.

Our own Grand Chapter was not obligated to observe that edict, but did vote to cease fraternal recognition, and correspondence with and visitation privileges.

Delegations from Greece have since visited the United States (and Miami) seeking to get back in good graces. But rumors tell us that now there are three Grand Lodges in Greece, and three Grand Chapters. The original charter issued to Greece by Gordon Merrick, in 1977 has not been returned, and is not the Supreme Grand Chapter. Some of the men of the original three Chapters are now located in other Chapters - and we do not know to whom they owe allegiance.

Your Committee recommends that no action be taken at this time, and that further studies be continued.

Your Committee is willing to acknowledge that there was a Grand Chapter in Columbia (contrary to last year's report), and if they request recognition, it should be granted.

The Grand Chapter in Newfoundland, organized last year by dividing the Grand Chapter of Nova Scotia, appears to be flourishing. Since we have recognized the Grand Chapter of Nova Scotia, and exchanged Grand Representatives in the past, it is recommended that we exchange Grand Representatives if they request.

**REPORT OF THE MOST EXCELLENT GRAND HIGH PRIEST
WILLIAM O. WALKER 1994-95**

To the Most Excellent Grand Chapter, Royal Arch Masons of Florida, Grand Chapter Officers, District Deputy Grand High Priests, Past Grand High Priests, members of the Grand Chapter, Distinguished Guests and Companions:

Welcome to the One Hundred Forty Eighth Annual Grand Convocation of the Grand Chapter of Royal Arch Masons of Florida being held this 31st day of May 1995. You honor us with your presence. I extend my personal greetings and hope that our hospitality has made this a pleasant and enjoyable experience.

STATE OF THE CRAFT

I believe that Royal Arch Masonry is alive and healthy in Florida. We are fortunate to have knowledgeable and dedicated Grand Line Officers to lead the Grand Chapter into the Twenty First Century and I believe that Royal Arch Masonry will flourish and prosper under this leadership.

Our Grand Line was twice broken this past year. Companion Kenneth K. Johnson, Grand Principal Sojourner passed to the Celestial Lodge on High on July 27, 1994. Companion Charles W. Wagner, Grand Master of the Third Veil moved from our Grand Jurisdiction and resigned effective September 1, 1994. All Grand Line Officers from the Grand Royal Arch Captain to the Grand Sentinel were moved up to fill the vacancies. Companion Steven Q. Steele was appointed Grand Master of the First Veil, Companion M. Charles Boice was appointed Grand Sentinel and Companion Leonard E. Whitehead was appointed District Deputy Grand High Priest of the Tenth Capitular District. All Companions were duly installed.

We experienced a net loss of 98 Companions for the Capitular year 1994. There were 239 suspensions, 320 exaltations, 62 reinstatements, 32 affiliations and the Supreme High Priest summoned 222 Companions from our midst. The net loss is an improvement over recent years and hopefully is a sign that we are reversing our membership loss. However, Companions, we are not yet selling York Rite Masonry as we should. Of the 820 Candidates raised to the Sublime Degree of Master Mason in the one day Grand Master's Class on March 26, 1994, less than one percent have petitioned for the degrees in the York Rite. We have a Blue Lodge Representative Program on going which must be vigorously supported by all three York Rite Bodies.

Twenty nine Chapters contributed to the Royal Arch Research Assistance Endowment Fund for a total of \$7622.67 or \$.87 per member. With some late returns we may yet reach our goal of \$1.00 per member.

Companions, there is one problem that has plagued us for years, it is the lack of communication within our Grand Chapter. It is essential that communication be greatly improved if we are to efficiently administer the affairs of our Grand Chapter.

RECOMMENDATIONS

1. Conduct Workshops at least once a year within each Capitular District for the purpose of assisting Subordinate Chapter Officers in the administration of Chapter business.
2. That each Subordinate Chapter send a copy of the Report of the Election of Officers to the Grand High Priest, Grand King and Grand Scribe in addition to the Grand Secretary.
3. Clarify when Dispensations are required.
4. Ensure that each Constituent Chapter has a current copy of the Constitution, Laws and Regulations of the Grand Chapter.
5. Make copies of the Constitution, Laws and Regulations of the Grand Chapter available to the District Deputy Grand High Priests during their term in office.
6. That the Ad Hoc Committee working on updating the Constitution, Laws and Regulations by comparing with the Grand Chapter Proceedings be continued until the task is completed.

GRAND SECRETARY'S REPORT

What has transpired in the Grand York Rite Office. We inherited a half dozen old metal filing cabinets that would hardly stand alone, an outdated typewriter, an antique calculator, and a copier that we could never get to work.

Today we manage a modern office for you. Starting out with some donations, physical help and a lot of good will, we painted the two rooms we rented, lowered the ceiling with acoustic tile, carpeted the floors and added a restroom.

We have always flown a United States Flag over our front entrance. With assistance from Comp/SKs Lank Green, George Malone and others, I have learned enough about computers to provide camera-ready copy for our Proceedings printer for several years. That represents a substantial savings, which with responsible fiscal management, we have acquired modern equipment without having had to ask for more from the General Fund.

We have a wide carriage Epson 1050 Printer 11 years old, and a five year old HP/LJ3 printer recently (guaranteed) serviced. Our seven year old 286 Computer and the new 486 DX2 (520m HD and 10m RAM) are both fully equipped and in daily use.

We have automatic pencil sharpeners and staplers, three typewriters in good repair, two electronic calculators, a Fax Machine, 3 phones (one line) with call-waiting capacity, a coffee maker, a refrigerator and a microwave oven.

REPORT OF THE GRAND CHAPTER HISTORY COMMITTEE

Our 1993 Report gives a brief coverage of the organization of the Grand Chapter of Royal Arch Masons of Florida in 1847. I have not as yet been able to locate proceedings for the years 1872, 1873, 1882, 1884 and 1939. It will be appreciated if any Companion can furnish or loan these five years of proceedings to the History Committee.

I have recently been in contact with the Library of the Grand Lodge AF&AM of Iowa and they advise me that they have copies of these five years which we are missing. If they do have them and will loan them to the Grand Lodge of Florida, it will give us research material for all of the years that our Grand Chapter has been organized.

The General Grand Chapter is presently in the process of printing a history of each of the Grand Royal Arch Chapters. I was assigned the writing of our Florida History which will be included in that printing. My writing was ten double-spaced typewritten pages and briefly included 1947 through 1993. Ten such pages was the maximum which each Grand Chapter was permitted to write. Our Grand Chapter will be notified when this History is available for purchase.

I wish to express my appreciation to our Most Excellent Grand High Priest for allowing me to serve our Grand Chapter.

LONG RANGE FINANCE COMMITTEE

The purpose of the Long Range Finance Committee is to provide oversight of the financial posture for the Grand Chapter, Royal Arch Masons of Florida. In this context, the Committee commends the Grand Treasurer for the prudent dedicated manner with which the surplus funds of this Grand Chapter continue to be invested.

Attention is invited to this Committee's report for 1994. (See pages 26 & 27, Grand Chapter, RAM, Proceedings for 1994). As an up-date to the statistics quoted therein, the Grand Chapter gained 418, lost 516; for a net loss of 98 members for the calendar year ending 31 December 1994. While this figure reflects a lesser loss than the previous five year average, it does reveal that we must continue a dynamic program to increase the membership and, thus the revenue, to meet ever rising costs and continue viable services for the Members and Freemasonry.

This Committee has reviewed the Joint Resolution submitted by Companion/Sir Knight John B. Fletcher, Chairman, Committee on Life Membership, for consideration at this Grand Convocation. The intent and purpose of the proposed Resolution is a timely attempt to improve the capital investment and, thereby, the dividends returned to the constituent York Rite Bodies.

It is noted that a number of Chapters have not yet adopted the Life Member Program. Some of the reasons advanced are: (1) lack of confidence in the program; (2) Falling and or fluctuating interest rates adversely affecting yield and (3) Lack of knowledge on the part of members.

The Perpetual Member Program adopted by the Grand Lodge of Free and Accepted Masons of Florida (R 26.05.1 & R 26.05.02 Grand Lodge Digest) receives exceptional praise from particular Lodges and participating Members for its simplicity and long range yield. There is a general sense evident among knowledgeable York Rite Members that adoption of the Grand Lodge Perpetual Member Program would improve the long term yield for the constituent Chapters and York Rite Bodies; and thus enhance the over-all financial posture.

It is therefore recommended that the Perpetual Member Program as implemented by the Grand Lodge of Florida be favorably considered; and, Constitutional amendments be prepared for adoption by each Grand York Body of Florida.



REPORT OF ROYAL ARCH RESEARCH ASSISTANCE 1994-1995

To the Most Excellent Grand Chapter Royal Arch Masons of Florida:

This is the report of progress and activities of the Royal Arch Research Assistance Program for the Capitular Year 1994-1995. The Companions of the Most Excellent Grand Chapter Royal Arch Masons of Florida continue their support of the philanthropy of the General Grand Chapter Royal Arch Masons International. The Companions of this grand jurisdiction have continued their fine support through the eighteenth year. The effort continues to be satisfactory, however, we again fell short of the goal that we have set for ourselves.

During the past Capitular year 30 constituent chapters, 4 honorary bodies and the "Ladies Boutique" have supported our charity. Contributions of \$8172.67 have been made during this reporting period of which \$7537.67 were made as general contributions and \$635.00 were made as memorial contributions. COMMITTEE ON WORK
